## ADC and GISIS Software License Agreement

This is a license agreement and not an agreement for sale. This license agreement (Agreement) is between the end user (Licensee) and ADC The Map People® (ADC) and GIS Integrated Solutions, LLC (GISIS), and gives Licensee certain limited rights to use the proprietary ADC and GISIS data and data updates, software and software updates, on-line and/or hard-copy documentation and user guides, including updates thereto, and watermarks for any images, software keycode or hardware key, as applicable (hereinafter referred to as "Data and Software"). All rights not specifically granted in this Agreement are reserved to ADC and GISIS.

# Reservation of Ownership and Grant of License:

ADC and GISIS retain exclusive rights, title, and ownership of the copy of the Data and Software licensed under this Agreement and grant to Licensee a personal, nonexclusive, nontransferable license to use the Data and Software based on the terms and conditions of this Agreement. From the date of receipt, Licensee agrees to use reasonable effort to protect the Data and Software from unauthorized use, reproduction, distribution, or publication.

### Copyright:

The Data and Software are owned by ADC and GISIS and are protected by United States copyright laws and applicable international laws, treaties, and/or conventions. Licensee agrees not to export the Data and Software into a country that does not have copyright laws that will protect ADC's and GISIS's proprietary rights.

### Permitted Uses:

Licensee may use the number of copies of the Data and Software for which license fees have been paid on the computer system(s) and/or specific computer network(s) for Licensee's own internal use.

Licensee may have the number of users access the Data and Software for which license fees have been paid on the computer system(s) and/or specific computer network(s) for Licensee's own internal use.

Licensee may use the Data and Software as a map/data server engine in an Internet and/or Intranet distributed computing network or environment provided the appropriate, additional license fees have been paid.

Licensee may make routine computer backups of the Data and Software during the term of this Agreement, provided that each backup copy is used only in accordance with the terms and conditions of this Agreement.

Licensee may use, copy, alter, modify, merge, reproduce, and/or create derivative works of the on-line documentation for Licensee's own internal use. The portions of the on-line documentation merged with other software, hard copy, and/or digital materials shall continue to be subject to the terms and conditions of this Agreement and shall provide the following copyright attribution notice acknowledging ADC's and GISIS's proprietary rights in the on-line documentation: "Portions of this document include intellectual property of ADC and GISIS and are used herein by permission. Copyright © 199\_ ADC The Map People and GIS Integrated Solutions, LLC. All Rights Reserved."

### Uses Not Permitted:

Licensee shall not sell, rent, lease, sublicense, lend, assign, time-share, or transfer, in whole or in part, or provide unlicensed third parties access to prior or present versions of the Data and Software, any updates, or Licensee's rights under this Agreement.

Licensee shall not reverse engineer, decompile, or disassemble the Data and Software, or make any attempt to unlock, bypass, or delete the watermark for any images, software keycode and/or

hardware key used, as applicable, subject to local law.

Licensee shall not make additional copies of the Data and Software beyond that described in the Permitted Uses section above.

Licensee shall not remove or obscure any ADC or GISIS copyright or trademark notices.

## Term:

The license granted by this Agreement shall commence upon Licensee's receipt of the Data and Software and shall continue until such time that (1) Licensee elects to discontinue use of the Data and Software and terminates this Agreement or (2) ADC and GISIS terminates for Licensee's material breach of this Agreement. Upon termination of this Agreement in either instance, Licensee shall return to ADC and GISIS the Data and Software, and any whole or partial copies, codes, modifications, and merged portions in any form. The parties hereby agree that all provisions which operate to protect the rights of ADC and GISIS shall remain in force should breach occur.

# Limited Warranty:

ADC and GISIS warrant that the media upon which the Data and Software are provided will be free from defects in materials and workmanship under normal use and service for a period of sixty (60) days from the date of receipt. Portions of the Data and Software herein have been obtained from sources believed to be reliable, but its accuracy and completeness, and the opinions based thereon, are not guaranteed. Every reasonable effort has been made to provide accurate Data and Software in this package. The Licensee acknowledges that the Data and Software may contain some nonconformities, defects, errors, and/or omissions. ADC and GISIS do not warrant that the Data and Software will meet Licensee's needs or expectations, that the use of the Data and Software will be uninterrupted, or that all nonconformities can or will be corrected. ADC and GISIS are not inviting reliance on the Data and Software, and Licensee should always verify actual map data and information. The Data and Software contained in this package ar e subject to change without notice.

EXCEPT FOR THE ABOVE EXPRESS LIMITED WARRANTIES, THE DATA AND SOFTWARE CONTAINED THEREIN ARE PROVIDED "AS IS," WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

## Exclusive Remedy and Limitation of Liability:

During the warranty period, ADC's and GISIS's entire liability and Licensee's exclusive remedy shall be the return of the license fee paid for the Data and Software that do not meet ADC's and GISIS's Limited Warranty and that are returned to ADC and GISIS or its dealers with a copy of Licensee's proof of payment.

ADC and GISIS shall not be liable for indirect, special, incidental, or consequential damages related to Licensee's use of the Data and Software, even if ADC and GISIS are advised of the possibility of such damage.

### Waivers:

No failure or delay by ADC and GISIS in enforcing any right or remedy under this Agreement shall be construed as a waiver of any future or other exercise of such right or remedy by ADC and GISIS.

# Order of Precedence:

Any conflict and/or inconsistency between the terms of this Agreement and any FAR, DFAR, purchase order, or other terms shall be resolved in favor of the terms expressed in this Agreement, subject to the U.S. Government's minimum rights unless agreed otherwise.

# Export Regulations:

Licensee acknowledges that this Agreement and the performance thereof are subject to compliance with any and all applicable United States laws, regulations, or orders relating to the export of computer software or know-how relating thereto. Licensee agrees to comply with all laws, regulations, and orders of the United States in regard to any export of Data and Software. Licensee agrees not to disclose or reexport any Data and Software received under this Agreement in or to any countries for which the United States Government requires an export license or other supporting documentation at the time of export or transfer, unless Licensee has obtained prior written authorization from ADC and GISIS and the U.S. Office of Export Control. The countries restricted at the time of this Agreement are Cuba, Iran, Iraq, Libya, North Korea, and Sudan.

Any software, documentation, and/or data delivered hereunder is subject to the terms of the License Agreement. In no event shall the Government acquire greater than RESTRICTED/LIMITED RIGHTS.
